COVID-19 waiver

- I understand that Dance Plus cannot be held liable for any exposure to the COVID-19 virus caused by any misinformation provided by personal screening or the health history provided by each student.
- Refund Policy – should the 2021-2022 season be interrupted in any way, Dance Plus agrees to refund class fees for any full months that have been cancelled, and are not in control of any refunds provided by costume companies and/or competitions.

Release of Responsibility (injury)

- I (parent) assume responsibility with respect to personal injury or loss of property that may occur to my dancer(s) by virtue of his/her participation with Dance Plus and during all times while at class.
- I (parent) agree to indemnify Dance Plus, its staff, affiliated companies, servants, or agents from all claims, demands, costs, expenses, actions, which might be made against Dance Plus arising out of injury, loss, or damage to my dancer(s) or property caused in any way connected with his/her participation.

Media / Communication Release Waiver (*Studio Policies Handbook pg. 6*)

- By enrolling my dancer(s), Dance Plus reserves the right to use photos/video of my dancer(s) for marketing and promotional purposes, including the Dance Plus website and social media channels. To ensure privacy, Dance Plus will not release any names of dancers for awards and/or scholarships unless verbally agreed upon by the family involved. To withdraw consent I agree as parent or guardian to decline authorization by choosing NO to the students media /photo release above.
- By providing a primary contact email address, I give consent to receive electronic communication from Dance Plus. (class information, newsletters, schedules, etc.). Without electronic communication you will be responsible for receiving your updated information via the Dance Plus Lumsden website.

Class Policy

- Classes are filled on a first-come basis.
- Dance Plus reserves the right to cancel or combine any classes that DO NOT have sufficient enrollment.
- Dance Plus reserves the right to shorten or increase class times in order to accommodate class enrollment numbers.
- Placement in all classes will be finalized at the discretion of the teachers based on experience, age and ability. Dancers will be split into levels accordingly.

Cancellation / Withdrawal Policy (*Studio Policies Handbook pg. 6*)

- It is the responsibility of the parent/guardian to provide formal notice to Dance Plus when withdrawing from class(es). I hereby, understand that failure to attend class does not constitute as a withdrawal.
- Dancers may drop or add classes, depending on availability, up until September 30th to ensure proper costume orders take place.
- Billing will NOT stop until cancellation notice has been received. You are responsible for all fees incurred until withdrawal notice is given to Deanna. (306) 949-6104
- Upon cancellation, the current month must be completed and paid for (after current month any pre-paid fees refunded and post-dated fees will be discarded).
- No refunds will be given for classes missed, costume costs or competition fees. Dance Plus is not responsible for any costumes left unclaimed by the end of the season.

Payment Policy

- By submitting enrollment you are committing to the classes chosen and MUST pay the applicable enrollment fees.
- Class Fees are based on lessons for the entire season, divided into 9 monthly installments (September thru May).
- All Fees are due on the 1st of each month. Any fees not paid in full by the 15th will be subject to a late fee of \$15.00 per month and will be applied to all overdue accounts not paid in full within 30 days.
- Service fee of \$25.00 will be applied to all NSF cheques returned for any reason.
- NO Refunds - Refunds will not be given for lessons missed for any reason of your own accord (i.e. illness, family vacation, short term injury, etc.).

Costume / Performance

- Dance Plus is a competitive dance studio, dependent upon the age, all competitive dancers are required to attend 2-3 competitions with their group(s) throughout the season.
- ALL seasonal dancers will require a costume for each class. Ordering takes place in November with full payment required before costumes will be ordered for your child.
- ALL seasonal dancers will perform in our year-end recital held in May.
